Southern Maryland Woman's League, Inc.
Special Post Covid-19 Nominating Committee Standard Operating Procedures (SOP)
Approved: June 24, 2021

1. The President is the Chairperson of the Nominating Committee. The Chairperson/ President shall determine the composition of the committee. The President shall recuse herself from the committee if her name is in consideration for the Board, and the Vice President, shall proceed as chair. If both the President and Vice President recuse themselves, the next available member of the Board of Directors shall serve as chair.

2. Objectives

- a. To encourage, solicit, and accept nominations for Board of Directors
- b. To present a list of qualified candidates to serve/fill Board positions.

3. Qualifications of Nominees

member in good standing who was an active member in good standing on March 23, 2020 is eligible to serve on the Board. A member is in "good standing" if membership dues and all outstanding invoices were paid in full on that date.

4. Composition of Nominating Committee

The Nominating Committee shall be comprised of no less than three (3) and no more than five (5) active members. Unless the President has been recused, the President shall count as one of the five (5) active members. No member of the Nominating Committee should be a candidate for the Board of Directors. A majority of the Nominating Committee shall constitute a quorum. A member of the Committee shall record minutes of meetings, recommendations and conclusions, and shall deliver a copy of such minutes to the Secretary of the Corporation.

5. Members shall be elected to all nine (9) Board positions with terms as follows: Five (5) two (2) year terms September 2, 2021 – June 30, 2023 and four (4) one (1) year terms September 2, 2021 – June 30, 2022.

6. Committee Calendar/Time Line

Immediately upon approval of this Special Post Covid-19 SOP, and within ten (10) days, the Committee Chair will appoint Committee members. The Annual Meeting will be held on September 2, 2021.

By July 15: The Committee shall conduct an in person or conference call at a time when all Committee members are available to attend. During this meeting the Committee will draft an email to the membership that describes the responsibilities and obligations of Board members, and the email will seek nominations for one (1) and two (2) year terms.

By July 23: The Committee will transmit agreed upon email and this SOP to the membership with a deadline for submission of nominations of August 6, 2021. This newsletter will serve as Notice of the Annual Meeting to elect the Board of Directors which is scheduled for September 2nd to allow for 30 days' notice of the SOP (per Bylaws).

Between July 15 and August 13: The Committee will

- a. Review all nominees and biographies prior to being presented to the Board of Directors
- b. Nominees who are not eligible to serve on the Board of Directors shall receive written notice as to the reason for their ineligibility.

By August 20: Present a slate of nominees to current acting Board of Directors.

By August 26: Send email to Membership with names and biographies of proposed Board of Directors before the Annual Meeting and encourage members unable to attend the Annual Meeting to cast their vote in writing via email prior to the meeting.

- a. Prepare ballots for distribution at the Annual Membership Meeting.
- b. Ballots will list the nominees in alphabetical order
- c. Blank lines will be included on the bottom for write in nominations or nominations from the floor.

Notice of 2021 Elections Continued

Voting at the Annual Membership Meeting:

- o Sufficient copies of the ballot will be available to take at least three (3) votes.
- o Sufficient pens will be made available for members' use
- o Sufficient copies of the by-laws and these procedures will be made available at the meeting.
- The names of those nominated will be read by the Chair of the Nominating Committee.
 Nominees will briefly introduce themselves. If a nominee is unable to be present, she may designate a proxy to present her qualifications.
- o A call for nomination from the floor will be made.
- o A member of the Nominating Committee shall instruct the membership present to add any nominees from the floor.
 - The Treasurer and Membership Chair shall verify that the member is eligible
 - Affirmation from the nominee that she accepts the nomination from the floor and is
 willing to fulfill the duties of a Board Member must be accepted by the Nominating
 chair via phone conversation, text, in person or email.
- If there are no nominations from the floor, and the number of candidates is equal to the slots open for election, the chair can take a voice vote, or can declare the nominee is elected, thus effecting the election by unanimous consent or 'acclamation'. (Roberts Rules of Order PG 35).
- o If a ballot is required, the procedures listed below will be followed:
 - Ten (10) minutes will be given to answer any questions regarding the voting process.
 - Once a member has voted, she will personally hand her folded ballet to a member of the counting team
 - The counting team will consist of three (3) members, one being the Chair of the Nominating Committee, and two (2) other members who did not serve on the nominating committee. These members will be selected from membership at large present at the election.

Absentee Votes via email:

- Absentee Votes must be sent to the Nominations Committee Chair no later than midnight of the day prior to the election (example: election is to be held April 2, ballots are due by 12:00 AM on April 1).
- o Each emailed vote will receive a confirmation of receipt from the Nominations Committee Chair.
- In lieu of printing a ballot, marking the preference, scanning, and returning the ballot, absentee voters may list the candidates for whom they are voting within the body of their email.
- The received ballots will be printed by the Nominations Committee Chair and presented to the counting team.
- o Should a member who voted electronically be able to attend the meeting, her electronic vote will be voided.

Counting Votes at the meeting:

- o The ballots will be counted three (3) times by the counting team and recorded on the ballot sheet after each count.
- o After the final count, the winners will be declared, and the ballot certification will be signed by the counters. The certification will become part of the minutes of the meeting.
- o The Chair of the Nominating Committee will announce to the membership at large the results of the election.
- o The non-elected candidate receiving the most votes shall be called upon to serve any Board of Directors position that becomes vacant during the next two-year term.
