Bitesize Bylaws! By Candice Kelly, Vice President

Members will elect members to the Board of Directors in June, assuming conditions have improved and we can meet again. Members can nominate fellow members or self-nominate. In addition, the Nominating Committee will solicit nominations. The Nominating Committee's goal is to present a slate of members with skills, talents ,and interests that are complementary to each other and the remaining board members.

President Suzanne Wible formed a Nominating Committee in accordance with Article VII of the Bylaws. It is comprised of Suzanne, Natalie McKinney, and Kelly McCormack.

Article V of the Bylaws states that the Board shall consist of no less than seven and no more than nine members. Board members are elected for two year terms and the terms are staggered. Board members are limited to three consecutive terms, but this condition can be waived by the Board. In June, members will elect four board members. Members do not elect the officers, that is, the President, Vice President, Secretary or Treasurer. Officers are elected by the Board of Directors at the first regular meeting of the board after the election, per Article VI of the Bylaws.

The following board members have completed their first two year terms, as follows: Pam Frank, Becky Hoffman, Candice Kelly (completing Ann Seely's term), Carole Lewis.

The Nominating Committee will likely contact the outgoing board members to see if they might accept nomination, and you will be hearing from the Nominating Committee as well, as they put together a slate for the Board. There are also nominations from the floor.

The Board of Directors is responsible for the managing, supervising and controlling the operations of the Corporation and Foundation. It establishes an annual budget and is responsible for the operation of all committees. The board establishes policies and procedures for the operations of the Corporation and Foundation. The Board of Directors meets monthly and each board member takes on additional responsibilities to ensure the smooth operation of the Corporation and Foundation.

Bi-Annual Grant Update | By Candice Kelly, Grant Committee Chairperson

Special thanks to the Grant Committee, Paige Gillentine, Rona Kelley, Carole Lewis, Brenda Lowe, Ruth Mudd, Katie Pierce, and Joan Rosier for their conscientious and attentive ranking of the applications, and creative recommendations. It was a pleasure working with you Ladies!

Because of YOUR DEDICATION AND SUPPORT of not one, but TWO, fundraisers, you will decide on a Bi-Annual Grant Recipient hopefully by the end of June.

Normally, we would have met our our Bi-Annual Grant Finalists and voted at our April meeting . . . but these are not normal times. Due to COVID-19, our April meeting was cancelled, and we will have to see what happens in May.

The Grant Committee submitted a Report to the Board and to the membership by email date March 17, 2020. Here are the highlights.

Finalists:

- Catherine Foundation education and supplies for new mothers, including non-English speaking mothers, who may lack support system
- Dream Queens re-structuring of Gals Lead Facilitator Training program for adult women to train teenage girls
- Poiema Movement this is a transitional home for homeless women and the funding requested is for programming, mentoring and general care.

Recommendations from Committee:

\$3,000 contribution to the each of the two finalists not selected.

Additional Information on Applicants not selected as finalists:

- Children's Miracle Network - requested funding for equipment that will keep babies' brains cool during emergency helicopter transport, which is necessary to protect against brain damage.

Recommendation from Committee: Invite CMN to a future meeting so that the membership can decide if it wishes to fund this equipment through a one-time special grant.

- Sagepoint Senior Services Foundation - requested scholarships for nursing student/employees.

Recommendation from Committee: Fund a \$1,000 CSM scholarship over four years (total of \$4,000).

- Jude House requested funding for a variety of projects to sooth clients. Although this project ranked high, it was not selected because JH was previously a recipient of the Bi-annual Grant and because we recently established a scholarship for JH clients.
- Life's Journey Writer's Guild to support grant funds needed.

Recommendation for Jude House and Life's Journey: \$1,000 contribution.


