SMWL is a long standing and reliable scholarship donor for the College of Southern Maryland. Not only is SMWL dedicated to CSM, member Brenda Lowe, serves as the Vice Chair of the CSM Foundation Board of Directors and over the years has served as the Chair of the SMWL Scholarship Committee.

In June, 2019, the membership formalized how we handle scholarships in the Foundation Bylaws as follows:

Section 6.2.2 Scholarship Committee – The Scholarship Committee shall consist a minimum of three (3) members. The Committee shall meet on a regular basis as needed.

The Scholarship Committee's purpose is to:.

- A. Serve as liaison with the College of Southern Maryland to identify recipients of SMWL scholarships
- B. Review applications and select scholarship recipients consistent with SMWL Policies and Procedures.
- C. Present an Annual Report and periodic updates to the General Membership on the SMWL scholarship recipients.

Our commitment to provide scholarships to worthy students is bolstered by an endowment that SMWL established almost 10 years ago. The rationale was that by establishing an endowment through the Community Foundation of Southern Maryland, we could fund a minimum scholarship in perpetuity, using the interest earned, never touching the corpus of our funds.

Initially, we earmarked the scholarships for women returning to the school, or single mothers, or women in need. Although a noble sentiment, we stepped out of our comfort levels this year, when we granted a scholarship to a very worthy young man, single father, and dedicated student.

We wish him success in his studies and life and look forward to hearing about his progress.

JMWL Foundation, Inc. - Grant Committee Report

The Grant Committee consists of at least two Board members, including the Treasurer, and at least three members who are not board members. The Grant Committee members are: Erica Abell, Buffy Giddens, Rona Kelley, Carole Lewis, Brenda Lowe, Joan Rosier. Candice Kelly serves as a non-voting member, responsible for the administrative details.

SMALL GRANTS

The Board is authorized to approve all requests for Small Grants of \$1,000 or less. Requests greater than \$1,000 require approval by a majority of the membership.

- The Grant Committee received, reviewed, and presented to the Board, and the Board approved the following Small Grants during the month of December:
- The Jude House, Inc. \$1,000.00 Christmas Gifts for client's children Sponsors: Terry Davis and Candice Kelly. (Note: Candice Kelly serves on the Board of Jude House and recused herself from voting on this matter).
- Grace Lutheran Church Nanjemoy Moms \$1,000.00 Christmas gifts for Nanjemoy Mothers in need Sponsor: Ann Rees. (Note: Becky Hoffman is employed by Grace Lutheran and recused herself from voting on this matter).
- Children's Miracle Network \$1,000.00 Mamma-roos for premature babies Sponsor: Laura Forbes.
- Hospice of Charles County \$500.00 to provide essentials for Hospice patients in need. Sponsor: Rona Kelley.

The Small Grant application is available on the SMWL website. Please encourage organizations that are designated by the IRS as 501(c)(3) to apply if their program meets our mission, and be sure to advise them to include your name as a sponsor.

BI-ANNUAL GRANT

Our Two Year Grant was renamed "Bi-Annual Grant" when our new Bylaws were approved last year. It will take a bit of getting used to, but this is a better description of the grant.

2018 – 2020 Bi-Annual Grant: The Center for Children was selected in 2018 and their grant is now concluded. To date, SMWL contributed \$17,035.00 to the Center for Children as follows:

- 11/27/18 \$2,735 Child Abuse Victims Teen Group journals
- 4/25/19 \$1,500 Sponsorship for Center for Children event
- 4/2019 \$1,800 Child Trauma Care support

At the January 21, 2020 the Board of Directors approved a final disbursement to the Center for Children for \$11,000 to support teens who have been victims of sexual abuse, to match a teen advocacy grant, and for additional journals.

At this same meeting, the Board approved updates to the Bi-Annual Grant Policies and Procedures.

2020 - 2022 Bi-Annual Grant

Applications were due January 31, 2020. The Grant Committee will review all applications and select three finalists, which will be announced by mid-March. The three finalists will be presented to the membership for a vote at the April 1st meeting.
